



## WAIVER AND RELEASE OF LIABILITY

I, for myself, and on behalf of my heirs, assignees, personal representatives, and successors, hereby release, hold harmless and promise not to sue Superstition Zipline, LLC and any parties, their officers, volunteers, staff, sponsor, and/or agents and Goldfield Ghost Twpn & Mine Tours, Inc., landlord, with respect to any and all injury and/or loss arising from my participation, whether caused by the negligence of the releasees or otherwise, except that which is the result of gross negligence or wonton misconduct, to the fullest extent permitted by the state of Arizona. The laws of the state of Arizona, exclusive of its choice of law/rules, shall apply to this waiver and release of liability agreement.
